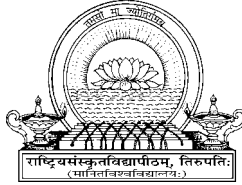

INTRODUCTION

Faculty of Education is an independent Faculty functioning under Rashtriya Sanskrit Vidyapeetha under Ministry of Human Resource Development, Govt. of India. The Vidyapeetha is the member of the Association of Indian Universities (AIU) and the courses of the Vidyapeetha are recognised by the Central and State Government.

The Shiksha - Acharya (M.Ed.) course of the Vidyapeetha is recognised by the National Council for Teacher Education (NCTE)

The Vidyapeetha has separate Hostel facilities for boys and girls. The selected students will be accommodated in the hostels as per the availability conditions according to rules and regulations of the Vidyapeetha.

GUIDELINES FOR PSAT - 2010

1. The Admission to Shiksha-Acharya Course is done through Pre-Shiksha Acharya Test (PSAT).

Application Cost : The PSAT applications can be had from the Convener, PSAT-10, R.S.Vidyapeetha, Tirupati - 517 064 by way of SBI/Andhra Bank crossed Demand draft for Rs.200/- (in person) Rs.250/- (by post) payable in the name of **Registrar, R.S.Vidyapeetha, Tirupati** from 8-3-2010 to 10-4-2010.

2. **Eligibility :** Minium eligibility required for appearing PSAT-10 :- A student desirous of seeking admnssion to Shiksha - Acharya course of study must have passed Acharya/M.A. Sanskrit / Vidwat Uttama or any equivalent examination with Shiksha Sastri or B.Ed. with Sanskrit Teaching Methodology or equivalent degree recognised by the Vidyapeetha with atleast 50% marks in aggregate in both.
3. **Age requirement :** A candidate seeking admission to Siksha Acharya course must have completed 21 years of age as on 1st July, 2010.
4. **Intake :** 25 seats are available in 2010-2011 session.

5. **Reservation** : Reservation will be made according to Govt. of India rules.
6. **Competent authorities for issue of certificates for reserved categories.** District Magistrate / Sub divisional Magistrate / Tahsildar/ M.R.O.
7. **Last Date** : For the receipt of Application form duly completed is on or before **10-04-2010** (5 p.m.) (R.S.Vidyapeetha is not responsible for any postal/courier delay.)
8. Inaccurate or incomplete / Xerox application form and that are received after the last date will be summarily rejected.
9. The admit card containing Roll no. and Centre will be mailed to the eligible candidates by Registered Post. If admit card is not received by 10-5-2010, contact the Vidyapeetha through phone (Ph. 0877-2288886 or 098858 81901) or by any other means.
10. The candidate appearing for the test should bring his/her own HB pencil, eraser and pen for the test.
11. Candidates who indulge in malpractice will be sent out of the Examination Hall.
12. **Centre of PSAT - 2010 : R.S.Vidyapeetha, Tirupati.**
13. **Date of PSAT - 2010 : 16-5-2010 (Sunday) from 10-00 a.m. to 12-00 Noon.**
14. **Duration of Test : 2 hours.**
15. **Model of Question Paper** : (The question paper will be in Sanskrit).

The question paper consist of 2 sections, with 100 objective type questions carrying one mark each.

Part - I – Education - 60 (60 Marks)

Part - II – a. General Awareness : 20 (20 Marks)

b. Language Proficiency : 20 (20 Marks)

Note: The candidates have to secure minimum 50% marks in each Part for passing PSAT i.e. 30 marks in Part-I and 20 marks in Part-II.

All the candidates should ensure that their application forms are filled in as per the instructions and have the following documents attached.

 4. Self addressed envelope - 2 (unstamped)
(to send Hall ticket or Call letter)
- b. Three recent passport size photograph should be attested and pasted one on application form one on Identification form and one on admit card.
- c. Attested copies of qualifying examination.
- d. Attested copy of Certificate in support of Age.
- e. In case of non-availability of certificate, a provisional certificate from the Head of the Institution last attended indicating the name of examination passed / Marks obtained in the examination and, in case of those who are appearing in qualifying examination 2010, a certificate from the Head of the Institution to this effect should be attached.
