
The Association at its 35th Annual Meeting held at Beroda in 1959, while considering the question of mutual recognition of degrees awarded by the member universities had resolved as follows :

The position is explained in the following statement at Sl. No. (vi)

- I) 2 (Two) / 3 (Three) passes at the GCE Advanced Level followed by 5 (Five) / 4 (Four) passes at GCE 'O' Level of approved examining authority in England are equated with +2 stage examination- the minimum eligibility for admission to first degree courses.
- II) 4 (Four) passes at GCE 'O' Level including English as one of the subjects are generally equated with 10 (Ten) years Matriculation. Some of the Universities accept 5 (Five) passes at GCE 'O' Level including English as equivalent to 11 years school education.
- III) 2 (Two) Advanced Level passes followed by 5 (Five) 'O' Level passes of West African Examinations Council, Nigeria have been recognised as + 2 stage qualification.
- IV) 4th (Fourth) Year Diploma of Secondary Schools (12 year course) awarded by the Ministry of Education, Iran has been equated with + 2 stage qualification.
- V) 12 years High School Graduation Diploma from the accredited Institutions in USA has been recognised as + 2 stage qualification

v) Phy, Chem, Biol/Maths & Eng are required for medical/engg admission at Indian Universities

The Degrees of Sastri, Acharya, Shiksha Sastri, Siksha Acharya, Vidyavardhi of Rashtriya Sanskrit Vidyapeetha are all recognised degree programmes equated with corresponding awards of other universities in the country. A copy of our circular addressed to all the universities in the country in this behalf is enclosed. Please write to us for any additional information. Please also inform us if there is any difficulty in acceptance of the qualifications of the Vidyapeetha. We will write to the concerned authorities immediately.




