Minimum Educational Qualifications: All applicants must fulfill the essential requirements of the post and other conditions stipulated in the UGC Regulation on Minimum Qualification for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010. They are advised to satisfy

- themselves before applying that they possess at least the essential qualifications laid down for various posts. No enquiry asking for advice as to eligibility will be entertained:

- 10. Full signature on the application is to be affixed. Paste (do not staple/pin) a recent passport size colour photograph in the space provided for at the right top portion on the first page of the application.
- 11. Please write name of the post applied for with subject and specialization (if any), reserved post or unreserved post, and applicant's name with full postal address on the backside of the Demand Draft without fail.
- 12. Reservations for SC/ST/OBC/PWD candidates exist as per the Rosters being maintained by the Vidyapeetha for various posts in accordance with the guidelines of the UGC.
